**Description** Implementation of some unit and area level EBLUP estimators as well as the estimators of their MSE also under heteroscedasticity. The package further documents the publications Breidenbach and Astrup (2012) <[DOI:10.1007/s10342-012-0596-7](https://doi.org/10.1007/s10342-012-0596-7)>, Breidenbach et al. (2016) <[DOI:10.1016/j.rse.2015.07.026](https://doi.org/10.1016/j.rse.2015.07.026)> and Breidenbach et al. (2018 in press). The vignette further explains the use of the implemented functions.

## Description

This package implements unit-level (Battese et al. 1988) and area-level EBLUP (Fay and Herriot 1979), and GREG (Sarndal 1984) estimators as well as their variance/MSE estimators. It also contains data and a vignette that explain its use. Heteroscedasticity can be considered.

## Details

The aim in the analysis of sample surveys is frequently to derive estimates of subpopulation characteristics. Often, the sample available for the subpopulation is, however, too small to allow a reliable estimate. If an auxiliary variable exists that is correlated with the variable of interest, small area estimation (SAE) provides methods to solve the problem (Rao 2003, Rao and Molina 2015).

The purpose of this package is primarily to document the functions used in the publications Breidenbach and Astrup (2012) and Breidenbach et al. (2018). The data used in Breidenbach and Astrup (2012) are provided. A subset of the data used in Breidenbach et al. (2018) is also provided for testing the functions. The vignette further documents the publication Breidenbach et al. (2015).

You might wonder why this package is called JoSAE. Well, first of all, JoSAE sounds good (if pronounced like the female name). The other reason was that the packages SAE and SAE2 already exist (Gomez-Rubio, 2008). They are, however, not available on CRAN and unmaintained (as of July 2011). They also do not seem to implement the variance estimators that we needed. So I just combined SAE with the first part of my name.

## Note

All the implemented functions/estimators are described in Rao (2003). This package merely makes the use of the estimators easier for the users that are not keen on programming. Especially the EBLUP variance estimator would require some effort.

Today, there are several well programmed SAE packages available on CRAN that also provide the functions described here. This was not the case when the first version of the package was uploaded. This package is therefore mostly to document the publications mentioned above. With respect to heteroskedasticity, this package also implements functions that, as far as I can see, are not available in other packages (as of May 2018).

## Description

Functions to calculate the EBLUP MSE (=variance). The wrap function calls all the other functions and calculates EBLUP, GREG, SRS, and Synthetic estimates for domain means as well as the variances of the EBLUP, GREG and SRS estimates.

### Details

Most users will probably only use the convenient wrap function. Nonetheless, all components of the EBLUP variance can also be calculated separately.

### Value

A component of the EBLUP variance (aka mean squared error). Which component depends on the function used.

The wrap function returns a data frame with many entries for every domain: The domain-level predictor variables obtained from the `domain.data`, the mean of the predictor variables and response (aka the sample mean or SRS estimate) observed at the samples, the number of samples (`n.i.sample`), the mean residuals of a `lm` (fitted using the fixed part of the `lme`) and the `lme` (`mean.resid.lm`, `mean.resid.lme`), the synthetic (`Synth`), EBLUP, and GREG estimates of the mean of the variable of interest, the `gamma_i` value, the variance of the means for the sample and GREG estimates (`.var.mean`), the components of the EBLUP variance (`c1-c3star`), the results of the first and the second method (cf. Rao 2003) to derive the EBLUP variance (`EBLUP.var.1`, `EBLUP.var.2`), and the standard errors derived from the variances (`.se`).

### Note

Currently, only random intercept mixed-effects models with homogeneous variance structure are supported.

### Description

The landsat data.frame is a compilation (by Battese et al., 1988) of survey and satellite data. It consists of data on segments (primary sampling unit; 1 segment =approx= 250 hectares) under corn and soybeans for 12 counties in north-central Iowa; see Details, below.

The landsat data.frame was made available by Tobias Schoch with the R package rsae. Since rsae was archived as of R 3.0.2, the data and this description was copied from rsae 0.1-4 in the archives.

### Details

The landsat data is a compilation (by Battese et al., 1988) of the LANDSAT satellite data from the U.S. Department of Agriculture (USDA) and the 1978 June Enumerative Survey.

**Survey data:** The survey data on the areas under corn and soybeans (reported in hectares) in the 37 segments of the 12 counties (north-central Iowa) have been determined by USDA Statistical Reporting Service staff, who interviewed farm operators. A segment is about 250 hectares.

**Satellite data:** For the LANDSAT satellite data, information is recorded as "pixels". The USDA has been engaged in research toward transforming satellite information into good estimates of crop areas at the individual pixel and segments level. A pixel is about 0.45 hectares. The satellite (LANDSAT) readings were obtained during August and September 1978.

Data for more than one sample segment are available for several counties (i.e, unbalanced data).

Observations No. 33 has been flagged as outlier (cf., Battese et al. (1988, p. 28).

The data landsat is from Table 1 of Battese et al. (1988, p. 29).

**Details**

SRS (simple random sampling) is assumed within each domain. If the direct estimator is not based on SRS, RV components of the results do not make sense.

**Value**

results           Area-level estimates and associated standard errors (SE). FH Fay-Harriot estimate (the standard area-level estimator), RV Rivest-Vandal estimate, considering uncertainty in variance parameters. `bias.sig.sq.v` Bias in random effect variance. `synth` Synthetic estimate. `trans.resid.v.i` Transformed residuals. The other parameters are details and are named as in the reference.

beta.hat           Estimated fixed-effects parameters.

des.mat            Design matrix.

Other list elements have descriptive names.

## Description

The only function that should be used is `sae.ul.f` which wraps the data preparation (`ul.data.prep.f`), parameter estimation (`ul.reml.f`), and EBLUP and MSE estimation (`ul.est.f`) functions. The other functions are helpers that do not need to be called by the user directly.

## Arguments

**Description**

Domain-level means of the explanatory variables obtained from digital aerial photogrammetry (i.e., means of all elements not just the means of the samples). The domains are 15 forest stands in the municipality of Stokke, Norway.

**Format**

A data frame with 15 observations on the following 5 variables.

`stand.ID` a factor with unique stand IDs.

`elev.mean` a numeric vector. Mean height obtained from digital aerial photogrammetry.

`elev.mean.sq` a numeric vector. Mean height squared obtained from digital aerial photogrammetry.

`k.i.one` a numeric vector of ones.

`sum.i.k.ij.sq.em.0.48.r` a numeric vector. Domain-level sums of the `k_ij` values of all elements that were not sampled. Needed if `fpc` cannot be neglected in EBLUP estimation.

`n.pixels` Number of elements with the domain `i`.

`plot.ID` a character vector with unique plot IDs.

`w.VMPRHA` a numeric vector. Timber volume per hectare (m<sup>3</sup>/ha).

`stand.ID` a factor with unique stand IDs.

`elev.mean` a numeric vector. Mean height obtained from digital aerial photogrammetry.

`elev.mean.sq` a numeric vector. Mean height squared obtained from digital aerial photogrammetry.

`k.ij.one` a numeric vector of ones (used in cases where heteroscedasticity can be ignored)

`k.ij.em.0.48` a numeric vector. `elev.mean` to the power of 0.48 for modeling heteroscedasticity.
